Dear Senators,

Thank you for your April 20, 2023, letter regarding the Native American Graves Protection and Repatriation Act (NAGPRA) and Harvard's efforts to meet the spirit as well as the requirements of the law and implementation regulations.

While I have asked the leadership of the Harvard Peabody Museum of Archaeology and Ethnology to provide more detailed information to your questions in the attached memorandum, Harvard University recognizes that ancestral remains and cultural items have remained in our museum collections for too long. Like many in the museum and university communities, Harvard has been working to confront the reality of a past in which academic curiosity and opportunity overwhelmed humanity. As an institution, we have apologized for the past collecting practices and we have accelerated our efforts to advance return in a way that is careful, respectful, and expeditious.

Harvard has an unusually large and unique engagement with NAGPRA. Over the university's hundreds-year long history, it has been designated by Congress and by many federal and state agencies as a repository of collections and key partner in the study of America's past. This history of collecting and the geographic breadth of the work have

meant Harvard, through the Peabody Museum, has needed to engage with almost all Tribes across the Nation. We have learned a great deal from these consultations, conversations, and relationships and appreciate the knowledgeable, generous, and thoughtful partners we have met as we strive to fulfil the legal, ethical, and moral imperative of NAGPRA.

I hope the attached is helpful to the Committee on Indian Affairs and to the Committee's important work examining NAGPRA.

Memorandum to Senators and Members of the Committee on Indian Affairs  
June 20, 2023

At the request of President Lawrence Bacow, I am pleased to provide further information on the implementation of the Native American Graves Protection and Repatriation Act of 1990 (“NAGPRA”) at Harvard University. The Peabody Museum of Archaeology and Ethnology (“Harvard Peabody Museum” or “Peabody”) has coordinated the university’s compliance (reflecting action around the collections at the Peabody and the Warren Anatomical Museum at the Harvard Medical School) with NAGPRA, employing experienced and expert staff who are dedicated to NAGPRA implementation.

### **Overview**

When NAGPRA was enacted the Harvard Peabody Museum cared for more than 10,000 Native American ancestors and many thousands of their funerary belongings from nearly every state in the Nation. The majority of the collection came from scientists, academics, and others, who worked during the late 19<sup>th</sup> and first half of the 20<sup>th</sup> century to study “America’s past” through large-scale archaeological excavations which were often supported by the Federal government. Harvard was among the most frequent recipients of federal collecting permits at that time.

Since the passage of NAGPRA, there have been shifts in guidance and requirements, which we have embraced, including an increased weight given to geographic affiliation and the scope and nature of treaty documentation. These changes have had significant impact on the nature and pace of implementation of repatriation.

Beyond the changes in federal policies, the university itself, under the leadership of President Lawrence S. Bacow, has worked to transform its stewardship of collections and museums across the campus. This includes the formation of the Peabody Museum NAGPRA Advisory Committee in 2020 that reviews and advises on NAGPRA implementation activities, and the Peabody Faculty Executive Committee in 2019 that provides broad counsel to the Peabody on issues related to the ethical stewardship of the collections.

In January 2021, Harvard University President Bacow publicly [apologized](#) for the university’s past privileging of those earlier academic pursuits that resulted in Harvard having collected thousands of ancestral remains. The university-wide statement was made alongside a [formal apology](#) from the Peabody. President Bacow also announced at that time the formation of a Steering Committee on Human Remains in the University’s Museum Collections, to make recommendations for the care of ancestral remains at the university’s museums. The Steering Committee’s Fall 2022 [report](#) made many recommendations, including that the university accelerate its implementation of NAGPRA and the ethical and moral imperative it represents. The work of the Committee also advances respectful stewardship of all ancestral remains at the university, more than half of which are not subject to NAGPRA.

### **Progress and Resources**

In 2001, the Peabody, as with other museums, completed its inventories for the ancestral remains that were known at the time, following a process guided by the U.S. Department of the Interior that involved an extension to the 1995 deadline. During the inventory process, the Peabody was in communication with all 574 federally recognized Indian Tribes and Native Hawaiian Organizations, as well as many state-recognized tribes and other native groups. Inventories are

updated if needed as a part of NAGPRA consultation and if additional information becomes available. As of June 1, 2023, the university has published 205 Federal Register Notices and returned 4,309 ancestors and more than 10,000 funerary belongings, sacred objects, and objects of cultural patrimony from 35 states to more than 250 Tribal Nations. Attached and available at this [link](#) is a full listing of the notices filed by the Peabody and the Warren Anatomical Museum. In addition, the Peabody has, following NAGPRA consultations and in partnership with Native Nations, returned other items that fall outside of NAGPRA. In 2023, a rare, complete kayak was returned to the community-owned Alutiiq Museum, Kodiak, AK to be cared for by the community (<https://alutiiqmuseum.org/press-releases/1844-harvard-university-transfers-historic-kayak-to-alutiiq-museum-january-24-2023>).

In Fall 2022, at the same time as the University's Steering Committee on Human Remains report was issued, the Peabody announced a NAGPRA Disposition Project to complete disposition of ancestors and their associated funerary belongings within the next three years. The Peabody has hired new staff dedicated to this project, more than doubling the number of people focused on implementing NAGPRA. The university now has one of, if not the, largest museum staff dedicated to NAGPRA in the country. This staff is continually engaged in ongoing consultations and is working to accelerate its work through proactive outreach to Tribes across the Nation. The Peabody typically consults with 50-75 different Tribes annually.

The foundation of this work is respectful consultation. Staff aim to be responsive and sensitive to Tribal timelines and priorities, which must take precedence over the Peabody's goals of moving quickly. For example, we have found some Tribes wish to first focus on working with museums in their state or region on repatriation or item return. Some Tribes prioritize synchronized repatriation among multiple institutions, while others are working in larger confederations around particular regions. Attentiveness to these Tribal efforts is a key responsibility of our staff and a crucial aspect of care and collaboration to advance the goal of return.

### **Reflections on the Existing Regulatory Framework**

Just as museums, academic disciplines, and society have recognized the legacy of the deeply flawed practices of the past, the U.S. Department of the Interior has also evolved its approach to the implementation of NAGPRA. Early regulation focused on the repatriation of ancestors and cultural items more easily identified with the Tribal nations of today. Later regulations focused on the return of ancestors with complex antiquity, that is, relationships of identity through time and across places, as well as those ancestors with little or no collections documentation.

We appreciate the work of the U.S. Department of the Interior, through the National Park Service that houses the National NAGPRA office, to keep regulations up-to-date and responsive to larger concerns. We would welcome additional clarity at a national level, because in many instances institutions must make decisions individually with the risk that interpretations may be inconsistent with decisions made at other institutions and museums. As an example, sorting through historic treaties, maps, and royal charters to determine which are authoritative government documents that can properly identify Tribal lands under the Act is a complicated task for Peabody staff and Tribal Nations alike. National NAGPRA briefly maintained, but recently removed, an online resource listing authoritative government documents that could be relied on in making decisions to associate and return ancestors and cultural items. This type of resource helped all institutions implement the regulatory emphasis on historical geographical territories that often requires consultations with multiple Tribal Nations.

We have also struggled with accommodating the interests of non-federally recognized Tribes.

While many of these groups are recognized in historical documents and often have formal recognition at the state level, they do not have status under NAGPRA. We have found in many instances that federally recognized Tribes are ready and willing to coordinate with them and act on their behalf, which can speed the process and make for stronger, widely supported outcomes. But there is not always inter-tribal cooperation, and this can create significant obstacles to completing a repatriation to a non-federally recognized tribe.

The following are responses to the questions contained in your April 20, 2023, letter. Certain responses refer to additional documents, and some responses contain website links that provide further information. The university's large collection and long history often require a longer explanation; however, we attempt to provide concise answers where possible.

We have also included examples to illustrate our points. These examples represent standard processes as well as details of interpretation for specific cases. From straightforward to complex, from 1993 to present, and sometimes in partnership with other entities (federal agencies and non-federally recognized Native American groups), these examples represent the process as it has changed over time since NAGPRA's enactment and provide a brief indication of the variety of factors accounted for within the process. Each case, however, is distinct. The documents that are required by NAGPRA as background for these Notices are publicly available from the National NAGPRA Program, and we are happy to provide further detail upon request.

- 1) **Please describe in detail how your institution determines if there is “a relationship of shared group identity that may be reasonably traced”<sup>6</sup> when your institution is determining the cultural affiliation of NAGPRA-eligible items or ancestral remains, and explain how your institution interprets and applies the terms “totality of the circumstances”<sup>7</sup> and “preponderance of the evidence” when making such determinations.<sup>8</sup>**

The university follows the steps detailed in the regulations to determine if the criteria for cultural affiliation are met. Each inventory entry documents the details for the particular case and has been submitted by the Peabody to the U.S. Department of the Interior National NAGPRA Program as specified by the regulations.

To determine cultural affiliation, given the scope of the Peabody's collection, we first assess if the ancestor or cultural item is “Native American” as defined in the Act. We then identify information for initiation of consultation to provide the final “required information” as required under Section 10.9(c) of the NAGPRA regulations. We assess the “readily available” documentation, especially as it relates to geography and culture, as outlined on the list in Section 10.2(e)(1). This information is provided to Tribes and Native Hawaiian organizations (in all cases requirements include Alaska Native Indian Tribes and Native Hawaiian organizations) according to Section 10.9(b) of the regulations.

We now use interactive online tools developed to share information quickly and accessibly with Tribes. We specifically request the Tribe's assessment of the evidence provided and request further information from the Tribe. We then confirm our understanding of the Tribe's evidence by reviewing the draft inventory finding together with Tribal representatives.

The nature of the history of the collection, which included large scale archaeological excavations

that involved detailed data collection, means there are multiple lines of evidence that may be used to examine and ultimately support the NAGPRA determinations. While helpful, that information is not a closed set, and we always look for ways to incorporate new understandings and knowledge that emerge from consultations, the work of other museums, or from information shared by the National NAGPRA office. Some cases are relatively straightforward, involving a single Tribal Nation or Tribal consortium. In other cases, information can support a specific Tribal affiliation even if there are multiple Tribes who have been in a particular area over time.

In these determinations, the Peabody interprets and applies the terms “totality of the circumstances” and “preponderance of evidence” according to the regulations. The “totality” includes careful review of all readily available evidence at the Peabody and information from the Tribe(s) in the nine categories described in the regulations (geographical, kinship, biological, archeological, anthropological, linguistic, folklore, oral tradition, historical evidence, or other information or expert opinion) in Section 10.2(e)(1). The Peabody interprets “preponderance of evidence” as we understand the regulation intends, i.e., that it is more likely than not there is a shared group identity.

- 2) Please describe the process your institution undertakes to determine—
  - a. When there is sufficient evidence to proceed with repatriation; and
  - b. When a cultural item or ancestral remain is culturally unidentifiable.

Each NAGPRA case is distinct and can run the gamut from straightforward to complex. Consultation frequently results in determinations of cultural affiliation. It provides the opportunity to bring new knowledge and traditional understandings into the process supporting the development and publication of notices leading to repatriation. There is sufficient evidence to proceed with “repatriation” (as defined in the Act and regulations) when it is more likely than not that the ancestor or cultural item should be returned to a particular Tribe. If not, the regulations point us to the term “disposition” for the return. Each matter must be handled on a case-by-case basis, and thus may differ in process, as the following examples illustrate:

An example of a recent relatively straightforward case for cultural affiliation is this 2022 notice to the Chickasaw Nation, when a cultural designation for an ancestor from an unknown location was found in Peabody documentation:

Another example, following initial NAGPRA implementation guidance from the U.S. Department of the Interior to focus on cases where cultural designation was present in Peabody documentation and otherwise readily identifiable in terms of cultural affiliation, was the repatriation of ancestors from Pecos Pueblo to the Pueblo of Jemez. This repatriation was among the largest to take place under NAGPRA comprising 1,921 ancestors and 553 funerary belongings:

Additional consultation led to cultural affiliation for ancestors and funerary belongings from Moundville, Alabama. When the first inventories were completed, consultation had not resulted in a relationship of shared group identity for ancestors and funerary belongings from the site. Subsequent evidence, which is detailed in this follow-up summary under the NAGPRA regulation’s Section 10.13 future applicability process, supported both a finding of shared group identity and identification of items as funerary belongings:

Consultation for ancestors and funerary belongings from New Hampshire and Vermont led to a special request to the Secretary of the Interior and formal support by Native American Tribes to recommend repatriation to non-federally recognized entities. The consultation process with neighboring and relevant federally recognized tribes and in-state non-federally recognized Native American entities resulted in evidence to support shared group identity with non-federally recognized entities and a mutually agreeable disposition to them:

If the consultation process does not result in cultural affiliation, then a determination of “culturally unidentifiable” is reached. When a cultural item or ancestral remain is culturally unidentifiable, Peabody follows the requirements specified in the NAGPRA regulations, Section 10.11. This requires that Peabody initiate consultation with officials and traditional religious leaders of all Indian tribes and Native Hawaiian organizations from whose Tribal lands such items were removed. If no Tribe agrees to accept the items, the Peabody relies on a recommendation from the Secretary of the Interior regarding disposition.

**3) Please describe the processes and methods your institution uses to gather and utilize Native traditional knowledge when determining the cultural affiliation of NAGPRA-eligible items or ancestral remains.**

As emphasized by NAGPRA, consultation is central to gathering and understanding Native traditional knowledge, which can inform any of the nine categories of evidence outlined in the regulations. Beyond direct consultation, Peabody NAGPRA staff work to stay informed and up to date with developments in Tribal communities and in other consultations at museums and agencies, and to incorporate new knowledge that may be emerging in those forums in the ongoing work at the university.

**4) Please provide examples of when your institution has used only Native traditional knowledge to culturally affiliate NAGPRA-eligible items or ancestral remains.**

Each of the numerous categories of evidence that are listed in NAGPRA’s definition of cultural affiliation has the potential to be informed by Native traditional knowledge. At the university, the history of collecting via scholarly archaeological excavations, and the direction of the regulations to consider all “readily available evidence,” usually means there will be documentation of some kind that is considered in addition to Native traditional knowledge.

Native traditional knowledge is evidence frequently learned via consultation. In the very first Federal Register notice submitted by the Peabody in 1993, which was for repatriation to the Pueblo of Zuni, Native traditional knowledge identified the Ahayu’ada as a sacred object and object of cultural patrimony. Another example of Native traditional knowledge being central to developing evidence is the repatriation of Haudenosaunee, New York Medicine faces, detailed in the summary and 2010 Notice:

- 5) Please describe each allegation filed with the National NAGPRA Program regarding your institution's failure to comply with NAGPRA, including a summary of the circumstances and outcomes of the allegation(s).
- a. If your institution requested an informal discussion with the Secretary pursuant to 43 C.F.R. § 10.12(f)(1) in response to an allegation, please provide copies of all documents provided to, or received from, the Secretary in connection with the request.
  
  - b. If an allegation of your institution's failure to comply with NAGPRA resulted in a notice of a failure to comply, please describe –
    - i. the steps your institution took to address the allegation, including the date on which the institution was informed of the allegation;
    - ii. the reason for the allegation, whether or not a request for informal discussion was made or occurred;
    - iii. the final determination of the Department of the Interior and the reason or reasons given for the determination;
    - iv. the court's decision in any appeal your institution filed challenging the Department's determination;
    - v. a civil action, if any, instituted by the U.S. Attorney General against your institution to collect a penalty; and
    - vi. any corrective or remedial actions taken in response to an allegation or series of allegations, including but not limited to changes to applicable policies or procedures.

The university has received two notices of failure to comply with NAGPRA.

In November 2009 members of Hui Malama I Na Kupuna O Hawai'i Nei (Hui Malama) alleged that Harvard's Warren Anatomical Museum had the human remains of at minimum eight Native Hawaiian individuals and had not completed an inventory listing the remains of these individuals by November 16, 1995. The university received notice of this allegation on April 28, 2010. In a written response to the U.S. Department of the Interior on June 14, 2010, the university described the history of the Warren, noting that by 1989 it was no longer a functioning museum. At the time, Harvard officials believed that all ancestral remains categorized by the Warren as "ethnological" had been permanently loaned to the Peabody as part of a major transfer to the Peabody on May 8, 1959. In 2007, Harvard Medical School hired a curator for the Warren collection. During this person's cataloguing of the collections, he identified potentially NAGPRA-relevant ancestral remains. After hearing this, the university immediately began the steps to determine if the remains were subject to NAGPRA and, having made this determination, took steps to repatriate them. On April 20, 2009, the university completed the inventory for the eight individuals that were the subject of the allegation and published a Notice of Inventory Completion on May 7, 2009.

On September 16, 2010, the U.S. Department of the Interior concluded that Harvard's failure to inventory these remains prior to November 16, 1995, was substantiated. The Assistant Secretary noted that Harvard came into compliance after discovering the existence of these remains and prior to Hui Malama's written allegation. Based on the totality of the evidence, the DOI determined that a civil penalty against the university was not an appropriate remedy.

On April 28, 2023, Harvard was notified that the U.S. Department of the Interior is evaluating an allegation that the Peabody may have failed to comply with NAGPRA regulations related to the university's handling of certain Woodbury Collection hair clippings. The university is in touch with the National NAGPRA program and is cooperating with the Department.

- 6) **Please describe the process your institution undertakes to complete summaries and inventories pursuant to 43 C.F.R. § 10.8 and 43 C.F.R. § 10.9, including the average length of time for completion and the average length of time to send the required Notice of Intent to Repatriate to the Manager of the National NAGPRA program.**
  - a. **For each summary prepared by your institution, please explain whether the determination listed in the summary as sacred, possibly sacred, patrimonial or unassociated funerary objects was made by i) museum staff or ii) in consultation with tribal representatives or iii) some combination of (i) and (ii).**
  - b. **For each inventory prepared by your institution, please explain whether the determination of human remains or associated funerary objects as either culturally affiliated or unaffiliated was made by i) museum staff or ii) in consultation with tribal representatives or iii) some combination of (i) and (ii).**

Each summary and inventory include the details for the particular case and have been submitted by the Peabody to the U.S. Department of the Interior National NAGPRA Program as specified by the regulations. Determinations required by NAGPRA and its implementing regulations are made by Peabody staff in consultation with Tribal representatives. Initial work is conducted by staff of Harvard, consultants to Harvard, or consultants recommended by the relevant Tribe, using “readily available information.” This information is provided to Tribes and Native Hawaiian organizations (in all cases requirements include Alaska Native Indian Tribes and Native Hawaiian organizations) according to Section 10.9(b) of the regulations, and the Peabody specifically requests a Tribal assessment of the evidence provided and requests further information from the Tribe. We confirm our understanding of the Tribe's evidence by reviewing the draft findings with Tribal representatives.

While each ancestor must be considered individually, consultation usually results in geographical grouping. Grouping can decrease the average length of time for completion of repatriation. The complexity and volume of organizing the groupings for the geographically varied collection at the Peabody significantly impact the process. There were more than 1,000 unique geographic locations, which included nearly every state. As a result of NAGPRA implementation, almost 600 sites are now represented, and they are the focus of accelerated grouped implementation efforts. A table listing the number of geographic localities by state is attached and available at this [link](#).

The time to prepare summaries and inventories, as well as to prepare and send a Notice of Intent to Repatriate to the National NAGPRA Program, differs in each case. A complex example of a multi-year effort proceeding to a Notice of Intent to Repatriate is the consultation for ancestors and funerary belongings from New Jersey, which spanned 1998 – 2021. This process took time because the Tribes wanted to coordinate dispositions among nearly 10 museums and large collections:

- 7) **Please describe the process your institution undertakes to determine if cultural items or ancestral remains are not culturally affiliated, including the length of time, on average, it takes to notify the Manager of the National NAGPRA program.**

Under Section 10.11 of the regulations, the process typically begins with a large number of officials representing Tribal Nations with aboriginal lands discussing how a mutually agreeable disposition will proceed. The regulations' emphasis on geography, rather than shared group identity, means that in some cases more than 50 Tribes, each with an aboriginal land right, have an equal role in directing a given disposition. Tribes have been developing regional groups to help streamline the obligation to consult with relevant Tribes while enabling consultation to move forward in an efficient way.

As noted above in the recent example of this work from New Jersey, NAGPRA's emphasis on consultation directs the pace of implementation. The Peabody follows this requirement and is responsive to Tribes. Some repatriations are accomplished within a few months, but many take longer and span a period of years. However, once a determination is reached the Peabody works expeditiously to submit the draft notice to the National NAGPRA office for publication in the Federal Register.

**8) Please explain any discrepancies between your institution's estimate of the number of cultural items and culturally unidentifiable remains in your institution's possession or control, and the number reported by the National NAGPRA Program.**

Historically, there have been discrepancies between the Peabody's submissions to National NAGPRA and the museum's database. The Peabody regularly checks that the data are accurate and informs staff at National NAGPRA of any errors, who are responsive in correcting.

Discrepancies can be large. For example, National NAGPRA removed museum information from Alabama from its inventory in 2005, and Georgia was not included in inventories in 2022.

Ongoing consultations can also lead to differences between the Peabody's estimate and the numbers reported in the National NAGPRA database, as there are time delays in updating the database when there are new notices and filings. For example, within the last three years, the Minimum Number of Individuals ("MNI") of ancestors was reduced as additional information during consultation allowed the reassociation of individuals. As part of another consultation, tribal knowledge enabled additional funerary belongings to be identified, and some belongings moved from the culturally unidentifiable category to being culturally affiliated.

**9) Please provide an inventory of any human remains that are in your possession, but controlled by another agency or institution. Please also note what effort, if any, has been taken to ensure the possession of these items comply with NAGPRA.**

With NAGPRA's passage, the Peabody prepared inventories for all known collections in its possession but controlled by another entity and, to the best of its ability, tried to determine which federal agencies had legal control of the individual collection. Agencies with collections at the Peabody, past and present, include the U.S. Department of Agriculture, Forest Service; U.S. Department of Defense, Navy; U.S. Department of the Interior, Bureau of Indian Affairs, Bureau of Land Management, National Park Service, and U.S. Fish and Wildlife Service; and the Smithsonian Institution. We note that the totality of the Peabody's multiple communication efforts with federal agencies over three decades are available in the public record of those agencies.
